



## 2021 – 2022 Registration & Financial Agreement

The Financial Agreement must be signed by the responsible party for the student listed below. Both the signed Financial Agreement and Registration Fee (per student) must be received in order to secure enrollment for the 2021 – 2022 school year.

### Registration Fee (Non-Refundable):

Early Registration: **\$390** (until May 17, 2021)  
Regular Registration: **\$440** (until July 19, 2021)  
Late Registration: **\$470** (after July 19, 2021)

### Instructional Fee:

**Option 1: \$795.00** due before 1<sup>st</sup> day of school  
**Option 2:** Quarterly payments of **\$198.75** due on or before first day of every quarter as noted on school calendar.

### Tuition Fee:

**\$4,750 (one child)**  
**\$8,265 (two children)**  
**\$12,113 (three children)**

### Select Payment Option:

- Option 1: Annual Payment** (2% Discount off of monthly tuition fee): **\$4,655.00**  
Tuition payments are due on or before first day of school.
- Option 2: Quarterly Payments** (1% Discount off of monthly tuition fee): **\$1,176 (Per Quarter)**  
Tuition installment payments are due on or before first day of every quarter as noted on school calendar.
- Option 3: Ten Monthly Installment Payments: \$475**  
Tuition is paid over 10 monthly payments (Aug – May) and is due on the 5<sup>th</sup> of every month (late fee imposed if payment received after the 10<sup>th</sup> of the month).  
\* **Annual and quarterly tuition payments already reflect a discount; therefore, there will be no additional waiving of convenience or Paypal fees.**

Convenience Fee (Fee is paid directly to a third party for the convenience of using a credit or debit card.) The fee schedule for Credit or Debit card transactions are as follows.

\* Due to Covid-19 SY 21-22 convenience and Paypal fee for monthly tuition ONLY will continue to be waived.

**Financial Aid/Assistance** – Applications are due on or before June 21, 2021.

- Aid is available on the basis of demonstrated need.
- All aid is provided on an annual basis. Applicants need to apply annually. Students receiving aid must maintain a cumulative 77%+ academic rating and satisfactory or better citizenship record.
- Applications for financial aid are available to parents when student is registered. The school is committed to assisting qualified applicants. If student does not meet academic criteria, the student will be put on probation for a quarter. If progress is not made, student will lose the financial assistance.
- Financial aid applications will not be processed until all supporting documents are completed and submitted to the Business Office by the deadline.
- Applicants will be informed of award on or before July 12, 2021.
- Qualified applicants will sign Promissory Notes on scheduled dates.
